<p>The Hospice is situated close to the City of Nottingham and has accessible links to public transport and a small amount of car parking. It is an old extended house built in 1857 that uses the ground floor accommodation to provide any patient related services. Access is adapted for wheelchairs; all facilities are wheelchair adapted and suitable for people with mobility issues. The ground floor has been extended offering areas for group activities as well as single rooms for 1:1 consultation. The grounds are accessible for people with mobility issues and an outside lift is also available to support this.</p> <p>The Registered Manager is a Registered Nurse and the organisation employs both Registered Nurses and Healthcare assistants as well as a Physiotherapist, Occupational Therapist and Complementary Therapist.</p> <p>The hospice offers Bereavement Support through Counsellors. The Hospice uses a range of volunteers to support services offered that are hospice based. All services are coordinated through a care coordination centre (based at the hospice location).</p> <p>As well as offering hospice-based services the Hospice delivers palliative Nursing and personal care into the community and patients own homes through their community-based Hospice in your Home (HIYH) services. HIYH services are available 24 hours a day, 52 weeks a year throughout the whole of Nottinghamshire with the exception of Bassetlaw.</p>	100%
